California EV drivers qualify for *major incentives!*

Clean Vehicle Rebate Project



State cash rebates of up to \$2,500! Qualifying is easy...

- Purchase or lease a new eligible plug-in electric vehicle and register it in California
- Minimum 36 month lease term or ownership required
- Available to California residents, businesses and public entities

Funding based on availability and is first-come, first-served.

Federal Tax Credit



Get money at tax time!

Federal tax credits range from **\$2,500** to **\$7,500** based on battery capacity.

DMV Clean Air Vehicle Sticker



EV drivers can use the carpool lane as a single occupant.



Recent Program Updates

- CVRP applicants must apply for the CVRP within six (6) months of the original purchase or lease date (effective as of July 15th, 2013)
- All Zero Emission Vehicles (ZEVs) are eligible for the full \$2,500 rebate



How do I apply?

Step 1

- Go to **www.energycenter.org/cvrp**
- Select vehicle and fill out application

Step 2

- Email sent with applications
- Mail in supporting documents
- Check mailed to applicant within 60 days

Administered by CCSE for the California Air Resources Board, the Clean Vehicle Rebate Project offers up to \$2,500 in electric vehicle rebates for the purchase or lease of zero-emission and plug-in hybrid light-duty vehicles. Applicants may apply for electric vehicle rebates only after the date of purchase or lease and must possess the vehicle for three years in California.
